Poštovane novinarke i novinari,

Danas delimo sa vama dokument koji dokazuje pravnu neregularnost Projekta Jadar, umešanost Rio Tinta u pravni proces naše države kao i ignorisanje zakonske procedure od strane Ministarstva rudarstva i energetike.

Šaljemo vam zbirku dokumenata, od kojih je najvažniji onaj koji smo dobili juče, 12.10.2022 (broj 5 na kraju dokumenta) koji dokazuju da su Vlada Srbije i kompanija Rio Tinto delovali protivno srpskoj regulativi i održavali zahteve za dozvolu za Rio Tinto **nakon** ukidanja Prostornog plana područja posebne namene.

Ovakvim postupanjem Vlade, premijerke Ane Brnabić kao i Ministarstva rudarstva i energetike nismo potpuno iznenađeni. Konstantno prisustvo kompanije u reklamnom prostoru kao i situacije poput trenutne u Rekovcu gde meštani protestuju nedeljama kako bi sprečili otvaranje istražne bušotine firme Balkan Resources, pokazali su nam suprotno od onoga što smo slušali sa ekrana, odnosno da sa litijumom u Srbiji **nije gotovo**.

Dear journalists,

Today we share with you a document that proves the legal irregularity of the Jadar Project, the involvement of Rio Tinto in the legal process of our country, as well as the ignoring of the legal procedure by the Ministry of Mining and Energy.

In this collection of documents the most important is number 5, the one we received yesterday, October 12, 2022, which confirms that the Government of Serbia and Rio Tinto acted contrary to Serbian regulations and maintained permitting processes for Rio Tinto after the cancellation of the Special Purpose Spatial Plan, which was the legal basis for all of Rio Tinto's work.

We are not completely surprised by this behavior of the Government, Prime Minister Ana Brnabić, and the Ministry of Mining and Energy. The company's constant presence in the advertising space shows us that contrary to what our prime minister told us in January, Rio Tinto is still here.

An attack on the Jadar valley is an attack on the rights of all citizens of this country. We may be tired and scared, but more than that, we are furious at the government's disregard for the will of the people, and we will stop at nothing to protect our fertile land, water, air, human rights, freedom of speech, and a healthy future.

Open letter to Serbian Prime Minister, Ana Brnabic

Please find our statements in this open letter sent to Prime Minister Ana Brnabić with the question: Were your hard-line promises that the "Jadar" project was gone forever, or were they just part of your pre-election marketing? 1. January 2022 Official Acts canceling the Jadar spatial plan, therefore all legal basis for the mine⁶
2. 01.06.2022 Ministry for mining response to our FOI request⁷ where they mention that Rio Sava has a request for exploitation permits in process for field no. 3. They include coordinates of the field.
3. Map⁸ showing that the coordinates of field three are actually the entire surface area of the mine.
4. FOI request⁹ sent this month for checking about cancellation of the permitting request.
5. **12.10.2022 - CONFIRMATION¹⁰ THAT THE REQUEST FOR THE PERMIT IS STILL VALID.**
